Notes to the Accounts

- 1 Bank fees includes admin fees charged by SIL (Societe Internationale Linguistique) in Cameroon who receive gifts and convert monies to cfas for WFC
- 2 Community Development and humanitarian needs No expenses of this nature from WFC funds in 2013
- 3 visa costs and health insurance cover Project Manager for visits to Cameroon
- 4 Staff expenses in Cameroon are for part-time Health Promoters who train villagers in use of water filters and basic hygiene
- 5 WFC covers the travel and accommodaton expenses in Cameroon for the Project Manager
- 6 WFC operates a Misubishi Pajero for team travel in the Ndop region
- 7 Double deduction error in March 2013 of €2395.73 has been adjusted in this figure
- 8 Pastor Edward handled payments to the Health Promoters and filter contractors in the absence of the Project Manager till end Sept 2013.
- 9 Expenses incurred by Project Manager and pending refund
- 10 Monies advanced to translation workers on behalf of Jon Blackwell, refunded by Jon in 2013
- 11 cfas = Cameroonian Francs
- 12 Nov / Dec 2012 Expenses accounted for in 2012 but not deducted from SIL Wells account until March 2012
- 13 Expenses were reduced in 2013 because a volunteer assisting fulltime in Cameroon meant that the Irish Program Manager only visited once in the year.
