Year ended 31 December 2016

Notes to the Accounts

- 1 In 2016, WfC Ireland partnered with Covenant World Relief and received the first tranch of funding for a specific project.
- 2 Our partner Water For Cameroon Ngoketunjia (WFCN) uses the monies sent by WFC Ireland for well-digging, filter purchase, and local Health Promoters costs. Their expenditure report covering the period to 2016 shows that 52.7% of monies received were spent on well digging, 21% on health promotion, 8.7% on administration costs, 3.6% on filters and the balance of 14% was on hands at end 2016.
 - The amount on the expenditure page for well-digging shows the amount spent directly by WFC Ireland and does not include the expenditure by WFCN.
- 3 WFC covered the travel and accommodaton expenses in Cameroon for the Project Manager 3 visits were made in 2016 and 2015.
- 4 Internet costs and printing in 2015. In 2016 rent was paid for a secure space to store supplies.
- 5 An account held in the name of our Project Manager with a previous partner (SIL Cameroon) was closed in April 2016.
- 6 Reconciliation of advances to Project Manager and expenditure incurred in Cameroon.
