#### **Notes to the Accounts**

- Fund-raising activities in Ireland were cancelled in 2020 because of the national restrictions due to the Covid pandemic. In 2021 we show income directly related to the GoFundMe appeal.
- The 2020 income was provided by Ripplezoo (Ireland) and Rotary Clubs in Canada for specific agreed projects. The 2021 figure relates to income from the Rotary Club in Kumbo.
- The higher gifts and offerings income in 2021 includes donations received following our reports evening.
- Recorded giving by Irish donors enabled WFC to claim back tax from Revenue under the Charitable Donations scheme.
- There were no team visits in 2020 or 2021 due to travel restrictions and lockdowns worldwide caused by Covid19.
- WfC received and passed on donations in 2020 specifically for humanitarian needs resulting from the conflict in North-West Cameroon, and towards the building of a new health clinic, store and training centre for our consultant, and for health promotion related to the Covid pandemic.
- 7 A store is managed by our Consultant in Cameroon at the clinic in Bamessing.
- The 2020 figure includes the cost of skype phone calls between Ireland and Cameroon by our Project Manager. The Board has Directors and Officers insurance cover.
