#### Year ended 31 December 2021

#### **Notes to the Accounts**

- Rotary Clubs in Canada provided funding for specific agreed projects through the Rotary Club in Kumbo, Cameroon.
- Recorded giving by Irish donors enabled WFC to claim back tax from Revenue under the Charitable Donations scheme.
  - WFC had shared with a missionary friend the cost of a 4 wheel drive vehicle in Cameroon.
- 3 As there was no expectation of further visits and use of it, it was agreed that the friend would buy out WFC's share.
- Expenditure on wells includes initial payments to the well constructor at end of 2022 for wells which were completed in early 2023.
- 5 There were no team visits in 2021 or 2022.
- A store is managed by our Consultant in Cameroon at the clinic in Bamessing.

  The Board has Directors and Officers insurance cover. The Miscellaneous category also
- 7 includes travel costs by our consultant to Douala to purchase pumps for wells and other equipment and materials.
