Notes to the Accounts

- In 2022 Rotary Clubs in Canada provided funding for specific agreed projects through the Rotary Club in Kumbo, Cameroon.
 - Recorded giving by Irish donors in 2021 enabled WFC to claim back tax from Revenue
- 2 under the Charitable Donations scheme in 2022. A claim is currently being prepared based on donations in 2022.
 - WFC had shared with a missionary friend the cost of a 4 wheel drive vehicle in Cameroon.
- As there was no expectation of further visits and use of it, it was arranged in 2022 that the friend bought out WFC's share.
- 4 There were no team visits in 2022, and one in 2023.
- As a result of the merger with Cameroon Medical, expenditure on humanitarian needs has increased.
- A store is managed by our Consultant in Cameroon at the clinic in Bamessing.
 The Board has Directors and Officers insurance cover. The Miscellaneous category also
- 7 included in 2022 travel costs by our consultant to Douala to purchase pumps for wells and other equipment and materials.
